Southeast Asia: We work in two of Cambodia's globally significant forests, Prey Lang and the Cardamoms, and partner with the indigenous Kuy people, local communities, and government agencies to protect critical forest areas and at-risk Asian elephant populations in ways that support traditional livelihoods and regional prosperity. We have also advanced Cambodia's newest marine protected area in Kampot province that that includes mangrove forests, sea grass beds and coral reefs. Key achievements this year include: 1) We completed field surveys to assess an unstudied population of endangered pileated gibbons; 2) Using results from our biological monitoring we advised the government on conservation zoning and reported on illegal wildlife trade and other key threats in Cambodia's forests; 3) Our team trained

Africa: Our mountain gorilla conservation efforts in Central Africa span more than 20 years and we now use these lessons to help turn the tide for critically endangered Grauer's gorillas in eastern Democratic Republic of the Congo. Together with the Congolese NGO Primate Expertise, we work in the upland sector of Kahuzi-Biega National Park and in adjacent indigenous Batwa communities. In Rwanda we partner with the women-led cooperative Imbereheza Gahunga to build household rainwater tanks, improving water access while eliminating the need to enter gorilla habitat. Key achievements this year include: 1) Our emergency support equipped 50 park rangers to resume anti-poaching patrols in Kahuzi-Biega National Park, dismantling 462 snares in core Grauer's gorilla habitat;

Global programs: We support shared learning across our global portfolio to improve conservation practice and outcomes and to inform new initiatives. For example, during the pandemic we facilitated virtual cross-site exchanges between field practitioners such as: 1) our partner in DRC discussed his approach growing Ape Trees with our Cambodia team who are starting nurseries to grow Elephant Trees; and 2) our botanist for Belize provided technical support for a new partnership in the United States focused on native tree restoration in the Chesapeake Bay watershed with land trust Delaware Wild Lands.







Other: Pt III, Line 4d - Americas: We continue to leverage more than a decade of success protecting marine turtles in the Eastern Pacific to support recovery of sea turtle populations in El Salvador. Together with Salvadoran partner ProCosta, we are working to restore the population of critically endangered hawksbill turtles at three sites in El Salvador, focusing on nest protection and hatcheries, community engagement and turtle monitoring and research. We also worked in Belize to identify, locate, and assess Belize's tree species while building Belizean botanic capacity and improving forest management and conservation. Key achievements this year include: 1) Protected 389 critically endangered hawksbill turtle nests and released 28,450 hatchlings; 2) Trained 100+ members of the local hawksbill conservation network, essential workers for identifying nesting females and protecting eggs; 3) Planned a new marine protected area to conserve critical hawksbill foraging grounds; 4) Completed a guide for timber tree species in Belize and implemented training modules with Forest Department staff to improve management of commercially valuable yet at-risk trees like Mahogany.
